

Advanced Skin Perfecting GLOWING

Description

Topical multiacid gel to improve skin texture* and radiance*.

Mandelic and salicylic acid with brightening, sebum regulation and dilated pores improvement properties. HAs low and medium molecular weight nourish and moisturize deeply the skin.

Enriched with Phytosphingosine, a natural precursor to ceramide and to sphingolipids complex, with anti-microbial and anti-inflammatory properties.

*Instrumental test performed by an independent Laboratory on 20 volunteers, in combination with Q.SUPREME face cream as post-application.

Ingredients

Mandelic Acid, Hylauronic Acid Low and Medium molecular weight, Salicylic Acid, Phytosphingosine.


Directions


- 1. Clean and dry the skin;
- 2. Apply **Advanced Skin Perfecting GLOWING** using a brush or with hands covered with nitrile gloves, following the directional guides and avoiding eye area and mucous membranes;
- 3. Deliver it to the skin with gentle circular movements until the full product absorption.
- 4. Evaluate customer's sensations and skin during application. If no extreme sensations are present, proceed with the application of 2nd and 3rd layers (3 layers totally, 3ml of product needed for face and submental zone)
- 5. Leave on the skin for up to 15 minutes.
- 6. Remove the product's residual with a wet wipe.
- 7. Dry the skin. Apply Q.SUPREME Face Cream for normal and sensitive skin, in case of facial treatment, or Q.BODY Replenishing Body Cream, in case of body treatment.
- 8. Continue to apply Q.SUPREME or Q.BODY on the days following application.

Frequency of application

Improve radiance 1 session

Improve skin texture 3 sessions, weekly (every 7 days)

Precautions

- Perform accurate skin assessment before the application.
- Do not use Advanced Skin Perfecting PLUMPING if patient is using Accutane (or other systemic acne treatment) or used it in the past 3 months.
- Never apply Advanced Skin Perfecting GLOWING after another AHA or BHA containing products, used in the day of treatment (scrubs of any type etc.).
- Do not use Retinol containing products at least 2 days before the treatment.
- Keep Advanced Skin Perfecting GLOWING at least 5mm away from the eyes and mucous membranes.
- If severe skin irritation occurs, remove the product by rinsing with cool water and apply the skin moisturizer.
- Do not apply to irritated skin or skin with open wounds or after extraction (cosmetic cleaning).
- Remind patient not to expose to the sun for 24 hours before or after the application of Advanced Skin Perfecting GLOWING. Then use a minimum SPF 30 on a daily basis.
- Slight reddening of the skin may occur for a limited period of time especially with sensitive skin types.

WARNINGS

For external use only. Keep out of reach of children. Do not swallow. Avoid contact with eyes. Do not use after the expiry date stated on the packaging. Store in a cool, dry and clean place, away from heat and light sources. Do not use in case of individual hypersensitivity to one or more ingredients. Apply on intact skin only. Discontinue in case of adverse reactions. Dispose the container in accordance with local regulations. Avoid release into the environment.

This product contains alpha and beta hydroxyacids (AHA, BHA) that may increase your skin's sensitivity to the sun and particularly the possibility of sunburn. Use a sunscreen, wear protective clothing, and limit sun exposure the week after the application
